### Grant Butte Natural Area Grows

**East Multnomah Soil and Water Conservation District (EMSWCD)** is pleased to have collaborated with Metro on the acquisition of 15 acres adjoining the existing Grant Butte Natural Area for wildlife habitat and public open space uses. This important acquisition of forested lands adds to and buffers the existing 88 acre natural area, which provides a significant expanse of natural open space for the residents of East Portland and the City of Gresham. Metro will engage the community in a public planning process to explore possibilities for expanding public access at the site when funding becomes available. The land will be owned and managed by Metro as part of their natural areas portfolio.

“We are excited to build upon our prior partnership with Metro to further enhance this community asset,” said Board Chair Rick Till. “These types of collaborations are critical to protecting the important natural resources that make our area such a special place.”

“Metro is proud to support the purchase of the property with \$210,000 from the natural areas bond measure voters approved in 2006,” said Jonathan Blasher, Parks and Nature director. “The new acquisition at Grant Butte Wetlands will help protect clean water, restore fish and wildlife habitat and provide people with opportunities to enjoy nature close to home.”

EMSWCD and Metro are grateful for the willingness of the property owner to convey the property and help enhance this important community asset. “We are glad to continue our history of public service in the area through ensuring the permanent conservation of this surplus land,” said Brian R. Stahl, General Manager of Rockwood Water People’s Utility District, the former owner of the property. “

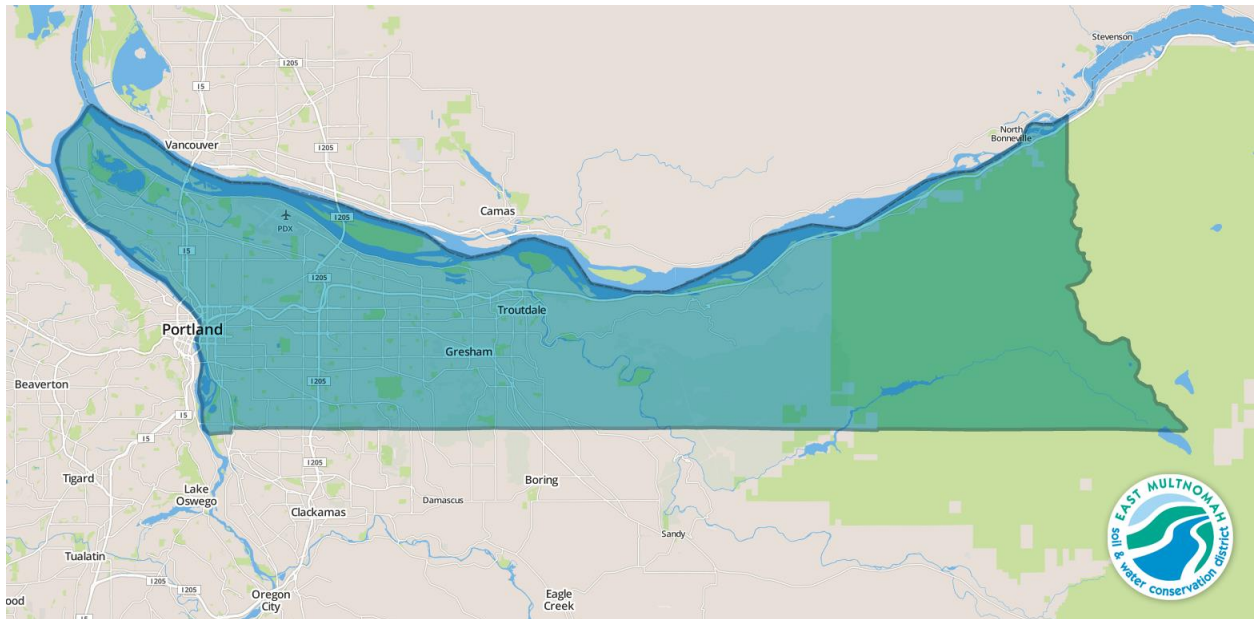
