A public hearing will be held by the Tax Supervising and Conservation Commission (TSCC) on the budget approved by the Budget Committee for the East Multnomah Soil & Water Conservation District, Multnomah County, State of Oregon, for the fiscal year July 1, 2022 to June 30, 2023. The hearing will be held via videoconference on Tuesday, May 17, 2022 at 4:00 pm. The purpose of the hearing is to discuss the budget with interested persons. **Proposed Change from Last Year's Levy Amount:** plus \$130,844
