East Multnomah Soil and Water Conservation District 2023 Partners in Conservation (PIC) Grant Review Committee Meetings

The East Multnomah Soil and Water Conservation District (EMSWCD), which serves all of Multnomah County east of the Willamette River, will hold meetings of the Partners in Conservation (PIC) Grant Review Committee on March 7th, 9th, and 17th 2023.

The purpose of the PIC Grant Review Committee is to review grant applications and recommend funding awards for EMSWCD's Partners in Conservation grants program. In January the EMSWCD Board approved the appointment of 12 community members and Board members Mike Guebert and Jim Carlson to the 2023 Partners in Conservation Grant Review Committee. The Committee is designed to include individuals from the community with diverse professional backgrounds, lived experience, and relevant expertise.
