A public hearing will be held by the Tax Supervising and Conservation Commission (TSCC) on the budget approved by the Budget Committee for the East Multnomah Soil & Water Conservation District, Multnomah County, State of Oregon, for the fiscal year July 1, 2023 to June 30, 2024.
