#### 5:19pm – LLP Outreach Plans

**Shipkey** has been working with Kent on next steps and timing for Outreach efforts for the Land Legacy Program. Aligned with the Communications plan, Shipkey is working with the CO&E team in March and April to create a plan for the LLP.



**Kent** We will be working with White-Brainard, who's been doing most of the Rural Lands outreach, like what's been done recently and ongoing for our Headwaters Farm Incubator Program (HIP). The broader organizational message development project has begun, and input from that project will be applied to both of those plans.

### 5:21pm – Oregon Agricultural Heritage Program (OAHP) Support

**Shipkey** OAHP was funded only once in 2022. There was support to fund in the last session, but there was inadequate time to consider the funding bill. There's now a push to bring it to the Short Session in February, asking for \$10.8 Million. The Board has expressed support for the program and this work, in fact we led a tour this past Fall for Legislators at Headwaters and Mainstem (Full Cellar) Farm and talked about the importance of OAHP with other partners. Today, we're asking for Zimmer-Stucky to sign a letter of support to be sent to legislators, and for the Board individually to reach out to legislators to indicate their support. Shipkey has created talking points and McAdams from Oregon Agricultural Trust (OAT) has created a template letter that the Board can use for their individual support.

#### Action Item: Shipkey to send the Board OAT's Letter Template and the letter of support to Zimmer-Stucky.

**Zimmer-Stucky** is in support of the letter, and the Board's collective and individual support. **Guebert** The Board has already approved the letter at the last LLC Meeting.

**Hamilton** Before the Mainstem Tour led by the Coalition of Oregon Land Trusts (COLT), Representative Sanchez, who holds a lot of power in terms of funding an initiative like this, did not originally support the program. She ended up visiting Headwaters Farm and Mainstem Farm on this tour, met with other legislators, met the farmers, met Cooper at Full Cellar, and has changed her perspective on it. Due to this, we are hopeful that we can get this project through this time.
